Savage Fire Department Auxiliary

On September 9, 1974, the wives of firemen in the Savage Fire Department identified a need in the community. What started with two women quickly grew to several with last names like McQuiston, Egan, and Bohn. The Savage Fire Department Ladies Auxiliary would peak with over 30 members paying yearly dues of \$1. The needs they filled were manifold and most centered around food. Delicious, comforting food!

"We originally started to support the firemen working hard to fight the fires," recalled one member.

When the firemen (all men at the time), were fighting big fires (think the Port Bunge grain elevator explosion or the Pollution Control fire) the wives made big lunches.

Realizing the kitchen was in bad shape and needed updating, the hot dish luncheon was started in 1976 to fund the need. The luncheons, which cost \$5 a head, were met with huge turnouts. With staples such as goulash, ham scallop, and green bean casserole, sometimes the roasters ran low.

Soon the kitchen had a new stove, more roasters, and serving dishes. The ladies expanded their culinary skills to Civic dinners, dinners for seniors, and Christmas parties. Then, a cookbook was published to raise funds. All the money raised went to support the Fire Department in many ways, such as with new rescue equipment and formal portraits.

The Auxiliary also provided emotional support to the wives, many with children, who worried about the safety of their spouses. They could gather for a cause when their husbands were gone for long hours. In those days the only form of communication with spouses was through a landline, not available on scene.

The Auxiliary would meet five times per year, usually in the fall and winter.

The word "ladies" was removed from the name in 1996 as roles changed and women started to serve as firefighters. If old meeting minutes are any indication, the Auxiliary stopped meeting in the early 2000s. Needed equipment was obtained budgetarily from the city. The firefighters started the Cadillac dinner and the bowling tournament to



fund extra equipment and cover the Halloween open house and Christmas party expenses.

I can still smell the deliciousness of the goulash and the coffee brewing.

I'll sign off now, as I need to start chopping onions and browning 12 pounds of hamburger!

Dan Patch Days

June 2023

The threat of severe weather put a damper on Dan Patch Days 2023, as all of the Saturday events were cancelled. Although we didn't get to meet and greet everyone at our booth and in the parade, the DPHS horseshoe hunt provided great momentum leading up to the weekend.

Website traffic steadily ticked up in the weeks and days leading up to Dan Patch Days as horseshoe hunt seekers inundated the site for new weekly clues. Daily traffic during the horseshoe hunt averaged 104 hits per day, which is higher than our normal daily traffic of between 30-50 hits. So far this year we have had 9,386 page views and 3,567 unique visits.

2023 Horseshoe Hunt Clues

The Dan Patch Historical Society's annual horseshoe hunt has taken place every year since 1996 and precedes the annual Dan Patch Days celebration.

Over the years, the hunt has grown in popularity, with people looking for the hidden horseshoe somewhere within the city of Savage, on public property. Here are the 2023 clues, along with the explanation, courtesy of our "clue master."

CLUE 1

'Tis time once again for the hunt to begin As Dan a shoe he did lose It'll take all ur brain, to discern where it's lain. With clues and button, it's news.

Explanation: Introductory Clue

CLUE 2

By his mark of an X in '60, Lincoln granted a plot quite nifty. For cultivation, fencing & stabled, Dan felt at home here and quite enabled.

n a document from the Military Bounty Land Act of March 3, 1855, John McCann was granted 160 acres in 1860. He signed with his mark of an X. The document was approved and signed by President Abraham Lincoln. The land was farmed. This clue draws one to be southwest portion of the city

CLUE 3

By '30 the land thrice sold, From TL to TK to EC. The trek is one to behold, Baptized in lore you would be

Explanation:

This park land changed hands from Thomas Loftus to Thos. Knafsey to Earl Cates. Trek is a synonym for journey, Journey Lane is near the park. Baptized refers to the water of Cates Lake.

CLUE 4

Old man Kneasfey had a farm... And on this farm there was a bench... And on this bench was thus etched... B & E, Oh my!

Explanation:

Knafsey, also spelled Kneasfey is referred to as "old man Kneasfey" in the Prior Lake Spring Lake Watershed district website info on Cates Lake. Cates Lake was once known as Kneasfy's Lake. While some addresses are listed as Prior Lake, the park is in Savage. The park has a bench on the west side that overlooks the lake and has the initials B & E etched on it.

Museum Partnership Continues to Grow

The Dan Patch Historical Society's partnership with the city of Savage is growing along with the expansion of the Savage Library.

As a part of the \$1.146 million project, the Museum/Heritage Room will be moving into the area that previously housed the periodicals. As a result, the space available to the DPHS will double in size and there will be greater visibility in the building. Both existing display cases containing M.W. Savage catalogs, buttons from all of the Dan Patch Days, M.W. Savage stationary, horseshoes, Dan Patch collector whiskey decanter, tobacco tin, items from Cargill, Camp Savage, and other collectibles will be moved. More display cases will be added and will include additional storage space underneath. The current file storage system will be moved, and so will all the banners, maps, posters, and other historic items. Plus, the new area will include a reading nook and an area for a table and chairs.

The display room near the front of the current entrance with a sulky, Dan Patch wagon, and items from the International Stock Food Farm will remain in place. The storage room area where overflow items are kept will also be retained. And the Dan Patch/M.W. Savage statue outside the building will be relocated to a new spot on the library's grounds.

The DPHS formed a unique partnership with the city in 1997 when the mayor and city council voiced the need to have museum space included to promote the rich history of Savage. Although the library is operated by the Scott County Library System, it is owned by the city, which provides space for the Senior Center and Savage Arts Council, and is used by several other community groups, and the public.



Ground was broken just after Labor Day for the library's expansion, but planning started in 2021 when the city used some of its American Resource Plan Act (ARPA) funds to evaluate space needs in the library. The analysis showed the need to double meeting room space, swap the magazine area and the museum, provide better access/visibility for the senior center and art space, create permanent Family Resource space, and provide security for an open library (6:00 a.m. to 10:00 p.m., seven days a week, with a special card).

Construction is expected to last six months. The city of Savage will be allocating \$966,795 in ARPA funds for the project and Scott County will be chipping in \$180,000. There will be no cost to the DPHS for the Heritage Room move and expansion.

Lynn Avenue RR Bridge Removed

A rather large piece of history was partially dismantled in September, when the spans of the Lynn Avenue railroad bridge were removed after being damaged by a truck.

The bridge carried a RR line founded by M.W. Savage, who announced plans in 1907 for a new railroad to serve southern Minnesota—the Minneapolis, St. Paul, Rochester and Dubuque Electric Traction Company. It was popularly called The Dan Patch Line and opened in 1910. The Minneapolis, Northfield and Southern Railway Company (MN&S), a Minneapolis-based short line railroad, bought the line in 1918, two years after Mr. Savage died.

The date 1926 was stamped in one of the concrete piers, so it's likely that the MN&S built the bridge to accommodate the growth of freight lines in the 1920s. The small local freight hauler served independently until 1982, when it was purchased by the Soo Line. In 1984, Canadian Pacific Railway gained complete control of the Soo Line and owns the route between West Minneapolis and Lakeville, although Savage to Lakeville does not operate.

Meet the Board
